1. Call to Order

The meeting was called to order at 5:31 p.m.

2. Adoption of Agenda

A. August 20, 2024, Parks & Recreation Meeting

5. Business/Updates

A. NYA Sports Complex Zellmann Field Light Pole Project

Hallquist shared that the Council expedited the process of approval to get 2024 pricing for the project. Clean N Seal Inc. for \$36,180 and M. Carlson Painting for \$43,249, for a total price of \$79,429 was approved for the project.

B. Kehrer Park

Commissioners discussed keeping Kehrer Park as a greenspace for the time being. Staff will research the cost of Yellowstone Trail signage.

C. West Carver Community Pool

Hallquist shared that staff is meeting with a contractor about the project. The goal is to have the improvements completed before opening the pool for the summer.

D. 2024 Goal Review

Commissioners reviewed the goals and noted that the following will extend to 2025:

- Outlot A project
- New Old Town Dedication on June 13, 2025
- Disc Golf Course at Prairie Dawn Park
- Adding music notes or other embellishments to the Willkommen Memorial Park Mural
- Continuing the All-Park Assessment, specifically with South Park
- West Carver Community Pool project
- Zellmann Field Light Project

Additional goals included:

- Dog Park at Friendship Park
- Planning an Arbor Day event

Comments included:

- Is it possible to save some of the large park trees with treatment rather than removal due to the Emerald Ash Borer?
- There is concern over the types of trees being planted in parks. The MN Department of Agriculture has a list of recommended trees to diversify breeds.
- Willkommen Park Playground impact material is dissipating. This playground project will be in 2028.

6. Community Education Update -

Dist 108 Community Ed Director Forster shared they are working on the next brochure and looking to partner with others for ads. The City could purchase an area to advertise for swimming lessons, senior center, senior dance, and using the walking track. Other updates:

- Working on ballfield partnerships
- New online facility calendar
- Will be asking civic groups for Music in the Park funding
- Veteran's Day was a successful event
- Craft Fair will be in new accessory gym instead of elementary school so event will be in one location


Business/Updates

A.NYA Sports Complex Zellmann Field Light Pole Project

Staff and the public service department are working on additional fencing plans for the entrance of the dog park. The PSD saved two hydrants from street projects this year to place within the park. - Two fire hydrants (not working hydrants)
- Signage
